

Such certificates are to be available for inspection by an HSE Inspector.

Certificates of Insurance must clearly state the name of the policyholder and, where applicable, make reference to insured subsidiary companies.

As required by your policy terms, any change to the name of the policyholder or the formation acquisition or divestment of subsidiary companies must be notified to Ecclesiastical.
